

2017 Heifer Mart
DISPLAY AREA TERMS AND CONDITIONS
(* Deadline – December 15, 2016 – Let us know by this date!***)**

(The Heifer Mart is strictly for Breed the display of registered Heifers for the purpose of herd promotion and if desired the selling on a private treaty basis of the display heifers. There is no show associated with the Heifer Mart. Only those materials associated with the promotion and advertisement of Heifer Mart females and your Ranches breeding program can be distributed. No alcohol or X-rated handout materials will be allowed! Anyone found in violation will be immediately shut down and asked to leave the grounds. No commercial exhibits are allowed.)

Following are the Terms & Conditions of the contract with the Western Stock Show Association for the Heifer Mart display area. **These TERMS will be adhered to without exception or you will be subject to stall forfeiture for future years.**

1. **POSTMARK:** The Contract and Payment for the space must be in the National Western Livestock Center offices **no later than December 15th. If contracts are not returned by the due date, those pens will be rented to other exhibitors. We will maintain a waiting list!**

2. **LENGTH OF DISPLAY:** Heifers are on display during the dates that your respective breed of cattle are showing at the National Western for either the Hill or the Yards. To know when your breed is at NWSS please refer to the Arrival and Release Schedules printed in the Premium Book. If you have questions call the Livestock Office at 303.299.5559.

3. **RESERVATION:** Display ties will be reserved in your name only upon receipt of payment. **Subletting of Heifer Mart ties is not allowed.** The Yards Committee and the Executive Livestock Committee have made this an official rule of the National Western Stock Show. **Failure to comply will result in the loss of your inclusion in future years.**

4. **ARRIVAL & DEPARTURE:** Upon arrival to the grounds, you **must unload at the chutes and then check in** with the Yards Accounting Office in the Livestock Center to receive your packet. Before you leave, you **MUST check out with the same Yards Accounting Office. You will need to get release papers! DO NOT LEAVE THE GROUNDS WITHOUT GETTING RELEASE PAPERS!** *Those who enter and/or leave without checking in or out will be subject to forfeiture of your display space in the future!!*

5. **HEALTH PAPERS:** You will need to have health papers on your cattle in the Herd Sire area. **In addition to the regular health requirements, you will need to have a negative BVD-PI test.** See Health requirements in the Livestock Premium Book or on our web site at nationalwestern.com. **You must turn papers into the Yards Accounting Office upon arrival! If you intend to sell your females at the NWSS you must comply with the health requirements listed in the Premium Book for Sale cattle. In most cases this will require a T.B. Test.**

6. **POWER:** We are limited on power sources. If you need power to your display, you will need to supply it through a generator. We are limited on the amount of power cords running throughout the area. They present too many safety hazards!

7. **SAND:** No sand allowed!

8. **SIZE:** All display spaces are tie rails and are 4 feet per head.

9. **SIGN ORDERS:** If we are making your sign, the sign orders should accompany your contract. SEE ADVANCE SIGN ORDER FORM for prices and fees. Cost for personal logos and additional artwork is determined by the Sign Painter and charged accordingly.

10. **COST:** All display ties will be \$100.00 per head. You may enter from 3 to 10 head per display.

11. **NIGHT TIE OUTS:** Every attempt will be made to have night tie out space for anyone who wants it.

12. **BADGES:** You will be allowed two (2) complimentary badges per display. Extra badges, may be ordered on the enclosed form or purchased upon arrival.

13. **Bedding:** Shavings and straw for bedding must be purchased through the NWSS.

14. **Tack Storage:** A designated area will be provided for tack storage and it must be kept in this area when not in use.
