

CARLOADS OF BULLS

RECEPTION OF LIVESTOCK

No animals will be allowed in the "Yards" or on "the Hill" either in tie outs or in the barns/pens prior to January 5. Due to our new extended livestock schedule, all livestock must comply with the Arrival and Release schedule for both the "Yards" and the "Hill". Thank you in advance for your cooperation.

ENTRY FEE: \$70 Per Load

Signs must be ordered using enclosed card.

1. Rules and Regulations: General Rules and Regulations apply to this division as well as those rules listed below and in specific breed divisions.

2. **All entries close November 20, 2018 and should be made through the National Western Stock Show or online at www.nationalwestern.com.** Late entries will be accepted after the postmarked entry deadline up to December 10, 2018 by paying an entry fee fifty (50%) percent greater than those listed. No entries will be accepted after December 10, 2018.

3. Animals must be entered and shown by the original breeder or first owner. Animals entered and exhibited in this division must be owned by an individual, corporation, partnership, and/or working family unit. Animals, or interest in animals sold by the original breeder or first owner, may be entered and shown by the original breeder or first owner after transfer of ownership. Animals purchased as embryos, flushes or pregnancies may be shown by purchaser as first owner.

4. Bulls exhibited in a carload may be shown in any other division of the show. Animals exhibited in the individual classes or in the Pen classes are eligible to be shown in the Carload classes and vice versa.

5. **The assignment of pens will be made at the time entry fees are completely paid and only to animals that arrive at the show. Entry fees do not dictate pen space. Specific pen requests must be submitted in writing and in the Yards Office by December 10, 2018. There is no guarantee the requests can or will be honored. Night pen and tie out space will be assigned separately from the exhibit pens. Pens on or near the Main Alley will not be used as Night Pens.**

6. Three (3) bulls per exhibitor from the Pens or Carloads divisions in the Yards may sell in the official breed association sale, with the exception of those breeds which specify otherwise, provided they are selected in time to be catalogued for the sale by the breed association except for the Grand Champion and Reserve Grand Champion Carload. In addition, uncatalogued bulls from the Carload division champion will be allowed to enter the sale not to exceed five (5) head from any breed. The breed association accepts full responsibility and liability of the transfer of the animal. The bulls are to be returned to their respective pens in the Yards immediately following the sale to remain on display until release time.

7. This classification is arranged for purebred registered breeding bulls in commercial quantities. A carload will consist of eight (8) yearling bulls or ten (10) bull calves. Entries that do not have the required number will be yarded outside of the bull show area.

8. All alternate bulls must be designated and processed on the day of check-in with the breed association.

9. Only those animals within the specific ages for the listed classes will be eligible to show (unless otherwise specified by breed association).

10. **All animals in the Yards during the National Western Stock Show, including Hill cattle sold or unsold, will be charged a yardage fee of sixty (\$60) dollars per head and a nonrefundable administrative fee of ten (\$10) dollars per head. Yardage fee and administrative fee must be paid at time of original entry. This also includes all sale cattle not entered in the show!**

11. In case animals are ruled out of competition, the pens may be allotted to other show exhibitors.

CARLOADS OF BULLS (continued)

12. All cattle entered in the carload division must be in their assigned pens on the date an time shown on "Yard" Arrival and Release Date schedule, otherwise pens will be reassigned. If Stock Show is notified, in writing, by January 1, 2019, that the exhibitor is cancelling their entry and releases the pen at that time, the yardage fee will be refunded after the show

13. Health papers must be turned in upon arrival. They will be checked at the Chute Trailer. Four copies on each animal are required. Please refer to Livestock Health Requirements in the front of the Premium Book.

14. **Trich Requirements:** Refer to Health Requirements section.

15. Exhibitors may be required to show the original registration certificate on bulls in carload classes. All animals competing must be registered with their respective breed association. Papers must be presented to the Superintendent upon request.

16. **Cattle originating from Canada coming to the National Western Stock Show for Show only, are required to have a legible ear tattoo. Any animals to be sold or that will stay in the U.S. are required to have a CAN brand and legible tattoo. (See Health Requirements and Brand Inspection Sections in front of the Premium Book for details.)**

17. All carload entries must pay the regular carload entry fee. Entry fees will not be refunded on any entries.

18. Champion premiums and ribbons will not be offered if only one (1) load is eligible for the breed champion class. Where there is only one (1) exhibitor in a class, the judge shall award only one cash premium in that class.

19. Carload bulls must be shown loose, with no halters permitted in the show ring while being exhibited.

20. All cattle entered in this division are subject to use for the Collegiate Carload Judging Contest.

21. **Tack Haulers will be available only from 7:00 a.m. - 9:00 p.m. daily.**

PEN & CARLOAD EXHIBITORS

One (1) bull from a pen/carload show and or one (1) heifer from a pen show are eligible to be entered and shown on the hill in an open show. Exhibitors may enter more than one (1) head from their pen/carload, but only show one (1) bull and or one (1) heifer.

The entry is due November 20th with all open/pen/carload entries. They must pay an entry fee for both shows (yards and hill).

The exhibitor must designate at time of processing with their breed association which bull/heifer they are showing on the hill.
