**Junior Market Swine are limited to 700 entries. Accepted entries will have been through an application process and only those who have been successful in the drawing process will be sent entry forms. Any exhibitor whose name is drawn but does not enter will be disqualified from the drawing process for one (1) year, unless Stock Show receives in writing a valid excuse for not entering.**

## SPECIAL RULES

1. General Rules and Regulations, Junior Livestock Show Rules and Regulations, and Auction of Junior Livestock Champions Rules and Regulations found in the Livestock Premium List apply to this division as well as the following special rules. All Participants must read and abide by these rules.
2. Entries must be made on official 2020 National Western Stock Show entry forms. **All entries must be owned by the exhibitor as of November 1, 2019.**
3. Animals entered in this division may be either barrows or gilts. Purebred market hogs must be pedigreed. Pedigrees will be verified and turned in at check-in.
4. **Participants are permitted to enter up to ten (10) market hogs and allowed to bring and show no more than two (2) market hogs. You must pay for all ten (10).**
5. Each entry must contain the signature of the County Agent or FFA Advisor. Absolutely NO late entries. The Primary Care Form must accompany your entry.
6. **Registration papers must have been transferred to or registered in the name of the junior exhibitor and NOT in a family or a farm name by December 1, 2019.**
7. This show is co-sponsored by the National Junior Swine Association and the Team Purebred Junior Association. To be eligible to exhibit in purebred classes of the Junior Market Swine Show, exhibitors must be 9 years of age but not 19 years of age as of January 1, 2020 and must be members of the NJSA or Team Purebred. (For membership information, contact NJSA @ 765-463-3594 or Team Purebred/Jeff @ 608-346-9561). All youth exhibitors MUST be certified in the Youth PQA Program. Exhibitors must arrive with your PQA/YQCA card. Crossbred exhibitors have the same age requirements.
8. **Official Weight.** The weight recorded at time of processing will become the official weight and cannot be changed. A weight card obtained from the superintendents office, must be filled out by all Junior Market exhibitors and turned in at processing with a called/declared weight. This will become the official weight. All junior market swine will be divided into classes according to this weight. No reweighs will be allowed once the animal has stepped off the scale. Minimum weight for junior market swine will be two hundred forty (240) pounds; maximum weight of two hundred ninety (290) pounds. A 5% weigh back will be allowed and the top 4-5 in each class are eligible for a weight back.
9. All swine entries must include ear notch numbers, and the notches should be uniform, healed, and match the registration paper per National Swine Registry rules. Any questionable notches will not be allowed to show. All hogs entered in breed classes will be checked at processing by NJSA/NSR and Team Purebred personnel. DNA will not be considered for eligibility when ear notches do not match entry cards. **DNA hair sample(s) are required for all swine entries. DNA sampling kits are automatically sent with official entry form to those participants successful in the application drawing process.**
10. The original registration papers must be presented at the time of processing. No copies will be accepted.

**JUNIOR MARKET SWINE DIVISION** (continued)

11. One bag of shavings per exhibitor will be charged with each entry. **NO OUTSIDE SHAVINGS WILL BE ALLOWED.** Additional shavings must be purchased through the National Western Feed Concession.
12. Hogs that potentially may be eligible for the Auction of Junior Livestock Champions may be reweighed. If there is a variance of more than five percent (5%) from the official weight, the hog will be disqualified. Processing weight will be official for sale weight.
13. A committee with the superintendent will inspect each hog for lack of quality (cysts, late cuts, etc.), over-age and staginess.
14. **Market Swine cannot use any compounds including hairdressing compounds, oils, paints, powders, glitter or other dressings at any time while on Stock Show grounds, from arrival to the time they are put on the truck. Water based conditioning products only!!. No oil or oil based products can be used due to packers concerns. Any swine caught using compounds will be chalked out and immediately disqualified. This also pertains to those hogs in the Auction of Junior Livestock Champions. No Glitter on Sale Hogs and oil only on feet.**
15. **Drenching will be allowed with drench guns, but the use of stomach pumps are prohibited.** Violation of this rule will result in disqualification with no recourse and be subject to other sanctions.
16. **ABSOLUTELY NO CLIPPING of hogs will be allowed on show grounds.**
17. Pen Assignments: National Western Stock Show management can assign pens or stalls to any exhibitor at its discretion in all species. Swine exhibitors with one (1) entry must provide their own divider and can be required to share a pen with another single entry. Stock Show will not provide dividers.
18. Special Breed classes will be provided for Duroc, Hampshire, Yorkshire, Landrace, Spots, Poland China, Berkshire, OPB (Hereford, Tamworth) and Chester White market hogs. Pure-bred classes will be broken by weight, with approximately 15-20 animals per class, depending on number of entries. No minimum requirement needed for breed classes. If fewer than 15 head in a breed they will be placed into a OPB class and then the decision on whether the breed champion and/or reserve breed champion is selected to the Auction of Junior Livestock Champions is strictly at the discretion of the National Western Mangement. All NJSA market hog entries must be registered Duroc, Hampshire, Landrace or Yorkshire market animals. All Team Purebred market hog entries must be registered Berkshire, Chester White, Poland China, Hereford, Tamworth or Spotted market animals.
  - A. All NJSA market hogs (Duroc-Hampshire-Landrace-Yorkshire) are to be guaranteed negative of the stress gene to be exhibited at a NSR or NJSA event. At a Team Purebred event, all Chester White market hogs are guaranteed to be stress negative. Berkshire market hogs must be stress negative and stress status must be on the pedigree.
  - B. NSR and NJSA reserve the right to randomly collect a DNA profile on exhibited animals for stress gene, parentage identification and breed purity at any event where registered animals are exhibited. This collection will be supervised by NSR or NJSA representatives.
  - C. All NJSA breed Champions, Reserve Champions and/or randomly selected market hogs may be blood tested for presence of the stress gene, parentage verification and breed purity.
  - D. NJSA and Team Purebred Champion and Reserve Champion overall premiums as well as breed Champion and Reserve Champion premiums will not be awarded until the DNA results are verified at the NSR office.
  - E. Any NJSA and Team Purebred market hogs that fail these DNA tests for the stress gene, parentage verification or breed purity will be asked to forfeit all show premiums and awards. If premiums and awards are not returned to NSR, the exhibitor will not be allowed to compete in future NSR, NJSA or Team Purebred events.
  - F. Failed NJSA test results will not be publicized except in the normal listing of cancelled pedigrees that is published in the NSR newsletter, For The Record, and the NJSA newsletter, The Pinnacle. Photos will also be removed from the NSR website, [www.nationalswine.com](http://www.nationalswine.com).
  - G. Market hogs must meet all registration eligibility requirements of their respective breed associations. NSR and Team Purebred representatives will inspect all NJSA and Team Purebred market hogs for eligibility.

**JUNIOR MARKET SWINE DIVISION (continued)**

19. The Stock Show will provide premium money and ribbons to winners in each class through 10<sup>th</sup> place. Banners will be awarded for Breed Champions and Reserve Breed Champions. The National Swine Registry and Team Purebred will provide additional matching premium money in the purebred classes. The following premiums will be paid for each class of Berkshire, Chester White, Duroc, Hampshire, Landrace, OPB (Hereford & Tamworth), Poland China, Spots, and Yorkshire market hogs:

21. In addition to the premiums paid in each class, the NJSA and Team Purebred will offer \$250.00 to the Champion Market Hog in the Berkshire, Chester White, Duroc, Hampshire, Landrace, OPB (Hereford & Tamworth), Poland China, Spots, and Yorkshire breeds if there are more than 15 head per breed.
22. The crossbred classes will be split into three (3) divisions – Light, Medium and Heavy. Banners will be awarded for Division Champions and Reserve Division Champions. The Division Champions and Reserve Division Champions will compete with the Breed Champions and Reserve Breed Champions for the Grand and Reserve Grand Champion Market Hog. In addition to the premiums paid in each crossbred class, The National Western Stock Show will offer \$250.00 to each of the Division Champions.
23. The Auction of Junior Livestock Champions will be held on Friday, January 24, 2020.
