#### 1. Entries:

- **A.** All NWSS livestock entries are online at <u>livestockentry.nationalwestern.com</u>.
- **B.** Entry Fees: Entry fees are \$100.00 per dog. There is a \$15.00 stock charge per run in qualifying rounds. Free parking is included with entry.

#### 2. Special Rules:

- **3.** Two (2) dogs per handler, per class. In the event entries exceed the limit, a random draw may be conducted to fill the appropriate classes.
- **4.** The Open Cattle Stock Dog Trial will be open to fifty (50) dogs for the qualifying rounds. The top 20 dogs from the qualifying rounds will advance to the Open Cattle Finals. This will be a time and points trial incorporating Outrun, Fetch, Drive, and Pen work. Course and rules will be explained at the handlers' meeting immediately prior to the event.
- **5.** Seventy-five percent (75%) of the entry fees will be jackpotted. Premiums will be paid to the top 5 places in the open cattle finals. First place will receive premium plus a buckle. Second through fifth places will be paid on a graduated scale.
- **6.** Class premiums will be paid out for the Thursday and Friday trials on the top five (5) dogs each day.
