Deadlines and Fees:

Online entries can be made at nationalwestern.com.

Online Entries: *Must be completed in the exhibitors name prior to entries closing to be eligible to show.*

- Online Entries Open: October 1st
- Online Entries Close: November 20th, 11:59 PM
- Late Entry: November 21st - December 10th, 11:59 PM
 - *Late Fee: additional \$35.00 per head*

Entry Rules & Regulations:

Entry Information:

1. All NWSS livestock entries can be made online at nationalwestern.com.
2. Entry Fees: Entry fees are \$105.00 per Pen of Three and \$115.00 per Pen of Five. Yardage and Admin fees are \$95.00 per head entered. This will allow for pre-bedding before arrival of all yards cattle night pens. Free power and parking are included with entry.
3. All Yards and Tied cattle day pens/display stalls will be pre-bedded for a fee of \$25.00 per head entered. Exhibitors may purchase additional bedding through the NWSS Feed Store online at store.nationalwestern.com or on grounds during the Feed Office hours should they choose to do so.
4. ASA registration numbers must be stated on entries.

Special Rules:

5. Animals must be registered with the American Simmental Association.
6. Two separate divisions will be offered. In the standard PTP pen show divisions, purebred and percentage bull and female shows are offered. The same animals cannot be shown in both a pen of 5 and a pen of 3 within this division. Animals competing in the purebred classes must all be registered as Purebred Simmental. Animals competing in the percentage classes must be at least 1/2 Simmental but less than Purebred Simmental. If not all the animals in the pen qualify as Purebred Simmental, the entire pen will be exhibited in a percentage class.
7. In the Phenotype and Genotype (P&G) pen division, a purebred pen of 3 bull show and a percentage pen of 3 bull show is offered. Bulls from the standard division, alternate bulls or additional bull entries may compose a P&G pen entry. (Entry fees adjusted or waived if "pen fee" already paid in standard pen show.) Bulls in the P&G division are required to have GE-EPDs at the time of check-in. No substitutes or alternates will be allowed in this P&G division after the pen animals have been declared at check-in.
8. Both divisions are ASA Progress Through Performance shows. Data will be printed in the show program. In the standard division, data will be provided to the judges to use in conjunction with visual appraisal. In the P&G division, data will be provided to the judges in advance, with half of the evaluation based on EPDs and \$ Indexes, composing 50% of the pen score. The second half of the evaluation will be phenotype placings on show day. The points from both scores will determine the winner. In the event of a tie, the tie will be broken based on the phenotype placing. Further details may be found on www.colorado-simmental.com.
9. For check-in, all female and bull pen entries will be weighed and measured. Each entry must have a legible tattoo, fire brand, or freeze brand that matches its ASA registration paper. Frame scores using Beef Improvement Federation guidelines and the most current EPDs on all entries will be collected. In addition to registration papers, exhibitors should provide:
 - Any bull fifteen (15) months of age or older must have veterinary proof of a semen test &/or breeding soundness exam

and must be proven as a satisfactory breeder.

- Any female eighteen (18) months of age or older must be a) certified pregnant by a licensed non-owner veterinarian or b) have certification that she has been used in embryo transfer. Females in classes 230 and 330 must be bred.

On bull entries, scrotal circumference measurements will be taken, plus each bull will be ultra sounded by a certified technician during check-in, at the owner's expense, with the fee payable to CSA at check-in. Animals that have not been processed will not be eligible to show. At their discretion, ASA staff may re-check tattoos &/or papers or pull DNA on any entry. Show management reserves the right to bar any animal or exhibitor from showing that does not meet the requirements of this show.

10. Grand and Reserve Grand Champion pens will have DNA samples pulled and tested for parental verification and genomics.

DNA collection will occur at the exhibition site and will be supervised and/or conducted by ASA staff. ASA reserves the right to pull DNA on any competing entry. Failure to submit to DNA sampling and/or testing will result in automatic disqualification.

11. CSA management reserves the right to modify classes as it sees fit, to facilitate a more uniform showing. Classes will be divided after check-in, according to the total days of age of the pen.

12. Genomic Enhanced EPDs: These are required in the P&G Show. For the regular PTP Pen Show, exhibitors are encouraged to run HD testing on their animals prior to the show. Genomic enhanced EPDs are noted in the show program.

13. Exhibitors participating in the Power Simmental program are required to enter and pay the \$250 gold-level participation fee directly to CSA. Exhibitors may download an entry form off www.coloradosimmental.com or request a form from CSA, 24614 County Road G, Sugar City, CO 81076. Rules printed on the form are binding. The winning "Power Simmental" (either bull or female) will be selected at The One & Only Sale.

Premiums: Colorado Simmental Association offers \$2,000 of the premiums in the following bull and female pen classes, and National Western Stock Show offers \$1,500 of the premiums. First place in each individual class will receive \$150 and the remainder of the premium money will be awarded through third place on a graduated basis to the other entries exhibiting. Premiums will be paid directly from the National Western Stock Show offices. Colorado Simmental Association also offers Champion and Reserve Champion awards.
