This is a NON-TERMINAL Junior Market Lamb show except for those who qualify for the National Western Junior Livestock Auction of Champions. Exhibitors who do NOT qualify for the National Western Junior Livestock Auction of Champions must remove their lambs from NWSS grounds after the conclusion of the show. Non sale-qualifying junior market lambs must be off of the NWSS grounds no later than Wednesday, January 20th at 9 PM. A harvest truck will NOT be provided. All lambs who successfully qualify for the National Western Junior Livestock Auction of Champions will be drug tested, DNA will be collected, and the animal will be harvested at the discretion of the National Western Stock Show.

- DNA kit Late Order Fee: \$250 per exhibitor plus \$5.00 for each kit ordered

- Online Entries Open: October 1st

- DNA kits and the provided signature form must be completed and postmarked on or before November 1st.

Ownership Deadline: November 1, 2026

General Rules:

General Rules and Regulations, Junior Livestock Show Rules and Regulations, and National Western Auction of Junior Livestock Champions Rules and Regulations found in the Livestock Premium List apply to this division as well as the following special rules. All Participants must read and abide by these rules. Again, this is a NON-TERMINAL show, except for lambs who qualify for the National Western Auction of Junior Livestock Champions. These animals will become property of National Western Stock Show.

Entry Information:

Entry Instructions:

Entry into the Junior Market Lamb Division consists of three phases. A valid entry must complete all three phases. At the conclusion of these phases, required forms and the DNA kit(s) must be mailed to the NWSS Livestock Office. Materials must be postmarked by November 1, 2026.

1. Phase 1: DNA kits must be ordered in the exhibitor's name. DNA kits can be ordered from nationalwestern.com and must be in the possession of the exhibitor before completing Phase 2. A \$5 fee is applied for each DNA kit. A maximum of 10 kits are allowed.
2. Phase 2: Exhibitors must complete all signatures on the provided signature form. All signatures are required for a valid entry. Missing signatures or an incomplete signature page will invalidate the entry.
3. Phase 3: Online entries must be completed in the exhibitors name. Completed DNA kits including a hair sample with at least 20 follicles, a copy of the entry confirmation receipt, and a completed signature form must be postmarked to the NWSS by November 1, 2026.

***National Western Stock Show highly recommends you use certified mailing when completing phase 3.*

4. NO late entries will be accepted.

Important Reminders

- Premise ID number is required. See “Premise ID” in Junior Market Rules.
- The Signature Form provided with your DNA kits must be signed by the exhibitor, the parent/guardian, and 4-H Extension Agent or FFA Advisor. No exceptions.
- Confirmation Receipt - Once DNA kit(s) and online entries are completed, exhibitors must print their e-mail confirmation receipt and send a copy in with their DNA kits and Signature Form.
- Certified Mail Recommended: We highly suggest sending DNA kits and entry confirmation receipts via certified mail to ensure confirmed delivery to the NWSS offices.

Entry Limitations:

1. Exhibitors are permitted to enter up to ten (10) Junior Market Lamb entries, but are only allowed to bring and show NO MORE THAN FOUR (4). Exhibitors must pay for all their entries, regardless of the number of animals exhibited. An exhibitor may not have more than FOUR (4) Junior Market Lambs on NWSS grounds. There are no refunds.
2. Entries entered in this division may be market ewes or wethers.

Entry Requirements:

3. Exhibitors must be 9-18 years old as of January 1, 2027.
4. Documents must be in the sole legal name of the participant.
5. All lambs entered may be subject to hair sample collection for DNA verification at the discretion of NWSS Management.
6. All Junior Market Lambs must present a Certificate of Veterinary Inspection (CVI) before entering NWSS show grounds. Please make sure to review the comprehensive list of Health Regulations prior to arriving on-site.

Animal Identification:

7. All junior market lambs must have a scrapie tag that matches the DNA packet and online entries by November 1st. This is an identification method used by the National Western Stock Show for all lambs.
8. Each animal must possess a single 840 RFID tag at time of entry. This 840 RFID tag number must be placed in the entry system at time of entry. The entered 840 RFID tag number must match at entry, on health papers, and at processing to avoid disqualification. Each animal must have a single 840 RFID tag in their ear at the time of processing. It is the exhibitors responsibility to ensure each animal only has one 840 RFID tag in either ear at the time of processing.
 - Any animal that has lost an 840 RFID tag from the time of entry until the time of processing must be reported to NWSS Livestock Staff prior to processing. These animals are subject to DNA comparison verification at the cost of the exhibitor.
9. Wethers having one (1) or both testicles contained in the body cavity are ineligible to show.

Show Rules & Regulations:

Other:

10. Ownership Deadline: All lambs must be owned by and in physical possession of the exhibitor by November 1, 2026.
11. Substitutions: No substitutions will be allowed. This applies to exhibitors and animals.
12. Barn Hours: For security reasons, all junior market steer, swine, sheep, and goat barns will be locked at 9 PM each evening and will open at 5 AM the following morning. No one is permitted to stay with the animals outside of barn hours.
13. Official Weight: An official weight card will be provided at the exhibitor meeting prior to processing. The official weight card must be completed and turned in to the designated area before the end of processing. This is the official weight and cannot be changed after the weight card has been turned in. Minimum weight for junior market lambs is one hundred five (105) pounds; no maximum weight. There is a 5% weigh-back tolerance.
14. Weigh-Back: A 5% weigh-back will be allowed and the top 4-5 in each class are eligible for a weigh back. Any junior market lambs outside of the 5% tolerance from the called weight will be disqualified.
15. Bedding: One bag of shavings will be pre-paid for on entries and provided to exhibitors upon arrival. Additional shavings and bedding must be purchased from the National Western in the on-grounds Feed Office. NO OUTSIDE SHAVINGS ARE ALLOWED. Carpet will be allowed but must be water-permeable.

16. Drenching: Drenching will be allowed with drench guns, but the use of stomach pumps is prohibited. Violation of this rule will result in disqualification with no recourse and be subject to other sanctions.
17. Water: A container, with water, must be present in each pen at all times.
18. Muzzles: Exhibitors may use meshed or plastic muzzles on lambs and goats on NWSS grounds. The style used must allow the animal to drink water.
19. Stalling: NWSS assigns stalls upon arrival. National Western Stock Show management can assign stalls to any exhibitor at its discretion in all species.
20. Junior market lambs may stall in the barn during the Breeding Sheep show if the exhibitor is entered with a breeding sheep entry.
21. ALL junior market lamb exhibitors will have a mandatory meeting where they will receive their weight cards on the Monday, January 18, 8:30 AM, in the Beef Palace.

Classification and Processing:

22. A minimum of fifteen (15) classified market lambs, or at the discretion of management, must be processed from any one breed to be eligible for a separate breed classification. If a minimum is not obtained, lambs will be shown with the crossbreds or other breeds. Junior Market Lambs will be classified at processing. Any reclassification is at the discretion of the classifier. Animals with obvious disregard for breed characteristics will be reclassified.
23. All breeds except Blackface will be required to classify at processing. If the entry does not classify it will be moved into the Blackface division.
24. All leg wraps must be removed for all breeds except Blackface during classifying.

Class Breaks:

25. All entries will be broken by classified breed and official weight declared on weight cards. Some classes may be divided into two or more sub-classes at the discretion of management, whose decision will be final. There is a maximum of twenty-five (25) per class and a minimum of fifteen (15) per class.

Grooming:

26. All Market Lambs must be uniformly slick-shorn. All shearing of lambs must be done only in the designated area prior to processing. Cordless clippers can be used after this time. All trim tables will be allowed at the discretion of the NWSS Management and Superintendents.
27. The natural color of a lamb cannot be altered using any artificial coloring.
28. Products that match the animal's natural color may be used in the fitting process from the knees and hocks down and on the switch only. For example, black products may be used on a black-legged animal, red on a red animal, and white on a white-legged animal. But under no circumstances can color be used to cover an animal's natural leg color.
29. Entries shall show no evidence of surgical docking, pro-lapses, purse strings, etc. If any of these are evident in any sheep, that animal will be disqualified from the show.
30. No fans will be allowed.

Showing:

31. Market lambs' front feet must be on the floor while showing.

Sale Qualifications:

Refer to the Junior Livestock Show Rules and Regulations for information on the Premier Exhibitor contest and qualification to the National Western Auction of Junior Livestock Champions. A total of 30 lambs, based upon judge placings in class, will be sold in the the National Western Auction of Junior Livestock Champions, which is held Friday, January 22, 2027.

All sale qualifying junior market lambs will be taken into the care and custody of NWSS following the Grand Drive until the National Western Auction of Junior Livestock Champions on Friday, January 22, 2027.

12. Substitutions: No substitutions will be allowed. This applies to exhibitors and animals.
13. Barn Hours: For security reasons, all junior market steer, swine, sheep, and goat barns will be locked at 9 PM each evening and will open at 5 AM the following morning. No one is permitted to stay with the animals outside of barn hours.
14. Official Weight: An official weight card will be provided at the exhibitor meeting prior to processing. The official weight card must be completed and turned in to the designated area before the end of processing. This is the official weight and cannot be changed after the weight card has been turned in. Minimum weight for junior market goats is sixty (60) pounds; the maximum weight of one hundred twenty-five (125) pounds. There is a 5% weigh-back tolerance.
15. Weigh-Back: A 5% weigh-back will be allowed and the top 4-5 in each class are eligible for a weigh-back. Any junior market goat outside of the 5% tolerance from the called weight will be disqualified.

16. Bedding: One bag of shavings will be pre-paid for on entries. Additional shavings and bedding must be purchased from the National Western Stock Show in the on-grounds Feed Office. NO OUTSIDE SHAVINGS ARE ALLOWED. Carpet will be allowed but must be water-permeable.
17. Drenching: Drenching will be allowed with drench guns, but the use of stomach pumps is prohibited. Violation of this rule will result in disqualification with no recourse and be subject to other sanctions.
18. Water: A container, with water, must be present in each pen at all times.
19. Muzzles: Exhibitors may use meshed or plastic muzzles on lambs and goats on NWSS grounds. The style used must allow the animal to drink water.

Grooming:

23. All shearing must be done before processing. Cordless clippers can be used after this time. All trim tables will be allowed at the discretion of the NWSS Management and Superintendents.
24. The natural color of a goat cannot be altered using any artificial coloring.
25. Products that match the animal's natural color may be used in the fitting process from the knees and hocks down and on the switch only. For example, black products may be used on a black-legged animal, red on a red animal, and white on a white-legged animal. But under no circumstances can color be used to cover an animal's natural leg color.
26. Horns: If horned, market goats must have horns tipped, not less than the diameter of a dime at the end. Tipping horns is not allowed on the grounds.

Showing:

27. Market goats' front feet must be on the floor while showing. The front feet can be picked up to set the animal and then placed back down on the floor.
28. Participants may use collars or collars with a short lead when showing. No extreme collars (spike, training) will be allowed in the show ring.

Sale Qualifications:

Refer to the Junior Livestock Show Rules and Regulations for information on the Premier Exhibitor contest and qualification to the National Western Auction of Junior Livestock Champions. A total of 18 goats, based upon judge placings in class, will be sold in the the National Western Auction of Junior Livestock Champions, which is held Friday, January 22, 2027.

The NWSS has limited space available, and therefore conducts an annual Swine Draw. Applications are made online and close on July 1st at 11:59 PM. There will be 480 exhibitors drawn. All applicants are notified via email in mid-July. If they were selected for the Draw, exhibitors are eligible to order DNA kits and then enter for the 2027 National Western Stock Show. Exhibitors who did not make the Draw are not eligible to enter or show junior market swine. Any exhibitor whose name is drawn but does not enter will be disqualified from the drawing process for one (1) year unless a valid excuse is received in writing before the start of the show.

Entry Information:

Entry Instructions:

Entry into the Junior Market Swine Division consists of three phases. A valid entry must complete all three phases. At the conclusion of these phases, required forms and the DNA kit(s) must be mailed to the NWSS Livestock Office. Materials must be postmarked by November 1, 2026. In order to submit entries for the NWSS Junior Market Swine Division, an exhibitor **MUST BE** selected during the Swine Draw.

1. To qualify for entry, exhibitors must apply for and be chosen in the Swine Draw (see Swine Draw Information). If an exhibitor is selected during the Swine Draw, they are eligible to complete the Entry Phases.
2. Phase 1: DNA kits must be ordered in the exhibitor's name. DNA kits can be ordered from nationalwestern.com and must be in the possession of the exhibitor before completing Phase 2. The first four DNA kits are free. A \$5 fee is applied for additional kits. A maximum of 10 kits are allowed.
3. Phase 2: Exhibitors must complete all signatures on the provided signature form. All signatures are required for a valid entry. Missing signatures or an incomplete signature page will invalidate the entry.

10. All purebred swine registration papers must be in the participants' name, not a farm name, by December 15, 2026. Original registration papers should be present at the time of processing. No copies will be accepted.
11. Only participants who successfully made the Swine Draw and ordered DNA kits are permitted to enter. No exceptions and no refunds.
12. All Junior Market Swine must present a Certificate of Veterinary Inspection (CVI) before entering NWSS show grounds. Please make sure to review the comprehensive list of Health Regulations prior to arriving on-site.

Animal Identification:

13. All swine must be ear-notched and healed. This is an identification method used by the National Western Stock Show for all swine.

14. Ear notches must be submitted at the time of entry and at processing, the ear notches from the entry will be confirmed. Entries whose ear notches do not match those submitted at time of entry are subject to disqualification.
15. Each animal must possess a single 840 RFID tag at time of entry. This 840 RFID tag number must be placed in the entry system at time of entry. The entered 840 RFID tag number must match at entry, on health papers, and at processing to avoid disqualification. Each animal must have a single 840 RFID tag in their ear at the time of processing. It is the exhibitors responsibility to ensure each animal only has one 840 RFID tag in either ear at the time of processing.
 - Any animal that has lost an 840 RFID tag from the time of entry until the time of processing must be reported to NWSS Livestock Staff prior to processing. These animals are subject to DNA comparison verification at the cost of the exhibitor.
16. Both gilts and barrows are allowed to show.

Show Rules & Regulations:

Other:

17. Ownership Deadline: All swine must be owned by and in physical possession of the exhibitor by November 1, 2026. Purebred registration papers must be in the exhibitors' name by December 15, 2026.
18. Substitutions: No substitutions will be allowed. This applies to exhibitors and animals.
19. Barn Hours: For security reasons, all junior market steer, swine, sheep, and goat barns will be locked at 9 PM each evening and will open at 5 AM the following morning. No one is permitted to stay with the animals outside of barn hours.
20. Official Weight: An official weight card will be provided at the exhibitor meeting prior to processing. The official weight card must be completed and turned in to the designated area before the end of processing. This is the official weight and cannot be changed after the weight card has been turned in. Minimum weight for junior market swine will be two hundred forty (240) pounds; maximum weight of two hundred ninety (290) pounds. There is a 5% weigh-back tolerance.
21. Weigh Back: A 5% weigh-back will be allowed and the top 4-5 in each class are eligible for a weighback while in the ring. Any junior market swine outside of the 5% tolerance from the called weight will be disqualified.
22. Bedding: One bag of shavings will be pre-paid for at time of entry. Additional shavings and bedding must be purchased from the National Western Feed Store in the on-grounds Feed Office. NO OUTSIDE SHAVINGS ARE ALLOWED.
23. Drenching: Drenching will be allowed with drench guns, but the use of stomach pumps is prohibited. Violation of this rule will result in disqualification with no recourse and be subject to other sanctions.
24. Water: A container, with water, must be present in each pen at all times.
25. Stalling: NWSS assigns stalls upon arrival. National Western Stock Show management can assign stalls to any exhibitor at its discretion in all species.
26. ALL junior market swine exhibitors will have a mandatory meeting where they will receive their weight cards on the Monday, January 18, 8:00 AM, in the CoBank Auction Arena.
27. NSR/Team Purebred: This show is co-sponsored by the National Junior Swine Association and the Team Purebred Junior Association.
 - To be eligible to exhibit in a purebred class of the Junior Market Swine Show, exhibitors must fall within the NWSS age requirements and must be members of the NJSA or Team Purebred. (For membership information, contact NJSA or Team Purebred offices).
 - All youth exhibitors MUST be certified in the Youth PQA or YQCA Programs. Exhibitors must arrive with their PQA/YQCA card. Crossbred exhibitors have the same requirements.
 - The original registration papers must be present at the time of processing. No copies will be accepted.

Classification and Processing:

28. All Junior Market Swine must be presented for inspection at the time of processing. Ear notches and 840 EIDs will be confirmed for all Junior Market Swine entries at processing. Purebred Junior Market Swine will be evaluated by representatives from NSR/Team Purebred for conformity with all registration eligibility requirements of their respective breed associations. An original registration paper must be presented for all purebred Junior Market Swine.

29. A minimum of fifteen (15) classified market swine, or at the discretion of management, must be processed from any one breed to be eligible for a separate breed classification. If a minimum is not obtained, swine from the breed will be shown with the crossbreds or combined with another breed at the discretion of show management. All barrows and gilts show together. Everything shows by breed and by weight.
30. A committee with the superintendent will inspect each hog for lack of quality (cysts, late cuts, etc.), over-age, and staginess.
31. If the minimum for a separate breed is met, breed classes will be provided for Duroc, Hampshire, Yorkshire, Landrace, Spots, Poland China, Berkshire, OPB (Hereford, Tamworth), and Chester White market hogs. Purebred classes will be broken by weight, no minimum requirement for purebred weight classes.
32. Representatives from NSR and Team Purebred/Certified Pedigreed Swine reserve the right to collect a DNA or blood from exhibitor animals registered with their respective association for evaluation of stress gene, parentage identification, and breed purity.
33. NJSA and Team Purebred Champion and Reserve Champion overall premiums as well as breed Champion and Reserve Champion premiums will not be awarded until the DNA results are verified at the breed association offices.
34. Any NJSA and Team Purebred market hogs that fail these DNA tests for the stress gene, parentage verification, or breed purity will be asked to forfeit all show premiums and awards. If premiums and awards are not returned to NSR, the exhibitor will not be allowed to compete in future NSR, NJSA, or Team Purebred events.
35. Failed NJSA test results will not be publicized except in the normal listing of canceled pedigrees that is published in the NSR newsletter, For the Record, and the NJSA newsletter, The Pinnacle. Photos will also be removed from the NSR website.

Grooming:

40. Market Swine cannot use any compounds including hairdressing compounds, oils, paints, powders, glitter, or other dressings at any time while on Stock Show grounds. Water-based conditioning products only. No oil or oil-based products can be used. Any swine caught using the above compounds will be chalked out and immediately disqualified. This also pertains to those hogs in the National Western Auction of Junior Livestock Champions. No Glitter on Sale Hogs and oil only on feet.
41. No clipping of hogs will be allowed on show grounds.

Sale Qualifications:

16. Bedding: A layer of pre-bedding will be provided upon arrival. All other shavings and bedding MUST be purchased from the National Western Feed Store on-grounds. NO OUTSIDE SHAVINGS ARE ALLOWED.
17. Drenching: Drenching will be allowed with drench guns, but the use of stomach pumps is prohibited. Violation of this rule will result in disqualification with no recourse and be subject to other sanctions.

But under no circumstances can color be used to cover an animal's natural leg color.
24. Each Junior Market Steer exhibitor will be allowed to bring one (1) blocking chute, onto the NWSS grounds. The required blocking chute permit must be purchased at the time of entry or in the Exhibitor Staging and check in office.
